## DATA PROTECTION INFORMATION CLAUSE

### Information on personal data protection.

The data you have provided us, as well as any data generated throughout the contractual relationship regarding you and your minor children and/or minors under your guardianship, will be processed solely for the purpose of authorising entrance control and admission to the Mad Cool Festival, in accordance with Article 25 of Law 17/1997, of 4 July, on Public Performances and Recreational Activities.

We process your data because:

- a) You give your consent for the processing of your personal data for a specific purpose, namely, the minor's access to the festival.
- b) The processing is necessary for the execution of the contract in which you are a party.
- c) The processing is necessary to comply with a legal obligation applicable to the data controller.

Only authorised personnel from our entity will have access to the requested information, as well as those entities that require access to it to provide our services, along with public or private entities to which we are legally obligated to disclose your personal data.

No transfer of your personal information to third parties or outside the European Economic Area is foreseen.

We will retain your data for the duration of our relationship and as long as required by law. Once the applicable legal deadlines have expired, we will proceed to delete them securely.

At any time, you may contact us to find out what information we have about you and/or your minor children and/or minors under your guardianship, rectify it if it is incorrect, and delete it once our relationship has ended, provided it is legally possible. You also have the right to request the transfer of your information to another entity (portability).
